Essential Duties and Responsibilities:

- Responsible for the safe and secure transportation of products to scheduled destinations.
- Operate trucks for the delivery, pickup, and relocation of products and materials.
- Provide outstanding customer service during delivery and pickup operations assisting with unloading product.
- Inventory products and record after every race event.
- Keep track of all permits, licenses, and insurances and notify the office before any expiration.
- Complete daily driver log according to State and Federal law.
- Verify load versus load sheet prior to departure.
- Records quantities and descriptions of the product being returned.
- Contacts Fleet Safety Coordinator with estimated leave time from destination
- Operate all Material Handling Equipment as required.
- Observe and notify management and contracted maintenance provider of anything that needs service performed.
- Must be able to receive electronic dispatches via personal smart phone
- Keep the truck neat and clean.
- Perform any other tasks assigned to support and improve the overall team operations.

- Valid CDL License and medical card required.
- Current endorsement required.
- Current tanker endorsement required.
- Must maintain all required certifications/ endorsements required by DOT, OSHA, MSHA, and company safety programs.

Thorough knowledge of traffic laws and defensive driving.

- Ability to operate and maintain equipment in a safe manner at all times.
